

# 5<sup>th</sup> Annual Senior DOUBLES (Handicap) Tournament

1. This tournament is certified by USBC and open to all members of the Greater Aurora USBC association who are 50 years of age and over as of October 22, 2011. Eligible participants who are not USBC members can bowl in this tournament by paying \$20.00 USBC-certification fees prior to participation. Entries can consist of both male, both female, or a mixed male & female pair with prizes being awarded in each group. Entrants will be allowed to participate in each category.
2. Tournament entry fee is \$36.00. Bowling Fees: \$18.00 – Prize Fees: \$14.50 – Expense Fees: \$3.50. No entry fee will be returned per USBC rule #314. All prize money will be returned 100% with the prize ratio of at least 1 in 5 entries in each category. All prize money and trophies will be based on handicapped scores only with money and trophies distributed within 30 days after the close of the tournament. In the event of a 1<sup>st</sup> Place tie, co-champions will be declared dividing the 1<sup>st</sup> & 2<sup>nd</sup> place winners' prizes. All other position ties will be divided equally.
3. Average qualifications:
  - a) highest 2010-2011 local association average for at least 21 games (book average will be accepted as official);
  - b) if "a" does not apply, highest local association average for at least 12 games as of the date of participation (a current standing sheet will be required to enter with this average.)
  - c) if none of the above apply, then an entering average of 170 for men and 140 for women will be used. Incorrect averages will be dealt with according to USBC Rule #319A, Item 3.
4. Handicap will be based on 100% of the difference between the bowler's entering average and 200. USBC rules 319-A-2, 319-C, 319-D and 319-E do not apply to this tournament.
5. **Tournament entrants can be either BOTH MALES, BOTH FEMALES or MIXED (MALE/FEMALE).** Entrants can bowl in each category with tournament prize money awarded according to the number of entries in each group.
6. Bowlers must check in 30 minutes before squad time. A bowler arriving after the tournament has started will be allowed to bowl with the score to count beginning with the frame being bowled. No score will be given for the frames missed.
7. Protests or appeals will be followed in accordance with USBC Rule #329. Scores not submitted to the tournament officials on completion of the (3) game series shall be disqualified and any prize money earned shall be forfeited.
8. **Entry close date is October 20, 2011.**
9. Entry fees must accompany entry blank. Make checks payable to "Greater Aurora USBC" and mail to address below.
